Minutes

Meeting of the Jurby Parish Commissioners held on Monday 13 December 2021 at 7.00pm Parish Hall, Bretney Road, Jurby.

1. The minutes of the last monthly meeting held on 8/11/21 were agreed and signed.

2. Matters arising from last meeting

- i) Clerk confirmed that he had reviewed Play Park Report and would meet with Andrew Livesey to discuss way forward.
- ii) It was agreed to push for a date early in New Year to discuss Jurby Development Plan
- iii) Clerk informed Board that he had contacted planning re Defribulator and was awaiting response.
- iv) The metal gate in to the school field was discussed. It was agreed that it was a DEC issue.
- v) Gough's completed the repair to the Parish Hall lights
- vi) Clerk circulated Municipal Assoc minutes prior to the meeting
- vii) Clerk confirmed Boundary Sign had been ordered. Delivery expected in January.
- viii) LQ confirmed that he had spoken to Bill Dale and asked for clarification re Beach Buddies issues with bins
- ix) Clerk asked all Commissioners to take their KYC documents to IOM Bank to complete the new mandate
- x) Commissioners agreed that the computer and printer bought for previous clerk should be retained for use by the Commissioners. Clerk to arrange collection
- xi) It was agreed to look at all services supplied to Board next year and where feasible put out to tender
- xii) It was agreed to accept NFU quote for Insurance for 2022 and look to put out to tender in Q3 2022
