**Meeting of the Jurby Parish Commissioners held on Monday 11th April 2022 at 7.00pm
Parish Hall, Bretney Road, Jurby.**

1. The minutes of the last monthly meeting were agreed and signed.

2. Matters arising from last meeting

- i) It was agreed nothing further to be done re Post Office
- ii) Clerk confirmed work at Play Park had been carried out
- iii) Clerk confirmed that still waiting for information from DOI re Jurby Development Plan
- iv) Clerk confirmed that planning was not required to attach defibrillator to Hall
- v) Clerk asked for email re dog poo byelaws to be resent to him
- vi) Clerk informed the Board that the plinth for the wheely bin would be done once weather improved
- vii) Clerk confirmed expressions of interest received and it was agreed that a proposal from each on the short list would be sought
- viii) LQ informed the Board that a new quote for the BMX track was still outstanding

3. Correspondence

- i) Clerk informed the Board of the hire of the hall and grounds by IOMKRA. This may be a recurring hire
- ii) Clerk informed the Board that DOIU had requested an out of hours number for the Commissioners. Clerk informed DOI that there was not a specific out of hours number.
- iii) Ducks crossing the road had been brought to Commissioners attention by a Parishioner. It was agreed that no further action required
- iv) Clerk had queried the concrete anti parking bollards on The Bretney with DOI. DOI suggested that the Commissioners may wish to take over this land. It was agreed that no further action was required

- vi) It was agreed to offer a potential spot at The Parish Hall or Play Park for a memorial bench

- ix) It was agreed that all would consider the Highways Maintenance Charter for discussion at next meeting
