Meeting of the Jurby Parish Commissioners held on Monday 16 June 2023 at 7.00pm Parish Hall, Bretney Road, Jurby.

Apologies:

1. The minutes of the last monthly meeting and AGM were agreed and signed.

2. Matters arising from last meeting

- i) Brett Thomas (BT) of the DOI updated the Board with regards to the Jurby Initiative. The Board were happy that it was progressing and that more details would be in the public domain soon. BT agreed to provide photo model of the houses as per the planning approval. BT left the meeting at 19:40
- ii) Clerk Confirmed that he was in contact with AG's office re draft byelaws for dog poo
- iii) It was agreed to ask again for details on plans for Palm Court stating that if no response Board would proceed with legal action
- iv) It was agreed Clerk would contact other Parishes regarding their plans for Paly parks and ways of funding
- v) Clerk confirmed that Music licence details had been sent to Parish Hall but not received. Licence to be submitted by 30 June
- vi) Clerk confirmed that Audit Exemption limits were being discussed this month
