1. The minutes of the last monthly meeting were agreed and signed.

2. Matters arising from last meeting

- i) The Clerk updated the Board that no further emails had been received regarding Jurby Initiative and that the relevant officer was on leave for a further week. Clerk to follow up and report at next meeting.
